Indiana eFMNP

What is Indiana eFMNP?

An electronic replacement for farmers' market nutrition program checks that is:

- Issued to eligible WIC recipients by local WIC agencies
- Issued to eligible senior recipients by local senior services agencies
- Available to produce growers who:
 - Grow at least 51% of the produce they sell over the course of a season
 - Are approved by Indiana WIC Commodities
 - Enroll in TotilPay Go
 - Provide details (addresses, dates, days and times) of their selling locations
 - Agree to post the authorized merchant sign when they sell
 - Attend virtual training provided by the state agency (*new enrollees only)
 - Have a smart device (iOS or Android) in current support status

How did we do it?


- Applied and received approval for two American Rescue Plan grants – one for each program

 - USDA FNS collaboration






Standard program funding

SFMNP 2023 \$144,228






WIC FMNP ARPA grant

- Farmer loaner equipment






SFMNP ARPA Grant








MyMarketLink app - Screens
